**ORDER :-**

Government in the G.O.Ist read above, have issued orders for supply of rice at the rate of *Rs.4/-* per K.G., with effect from 01-06-1997 to all Hostels, Ashram Schools and Residential Schools, Residential Junior Colleges of SC, ST & BC categories and other institutions under the control of Social Welfare Department and also to Homes and Hostels for Physically handicapped, Residential Schools for Deaf and Blind for Boys and Girls Handicapped children State Home, Services Home, Children Home Collegiate Girls hostel, Creech centres (to the children of Agriculture Labour Women) Baiwadies, Regional Training Centre, Women Welfare Branches, Mobile Creaches, Women and Child Welfare centres and Vocational Training Centres which are under the control of Women Development and Child Welfare Department.

2. In the reference 2” read above, the Principal Secretary to Government, Social Welfare Department has requested to issue necessary orders extending the scheme of supply of rice @ *Rs. 1/-* per K.G., to the all Hostels, Residential Schools, Ashram Schools, Ananda Nilayams, Children Homes run by the following Departments:

- i) Social Welfare Department including Andhra Pradesh Social Welfare Residential Educational Institutions Society and Victoria Memorial Home;
- ii) Tribal Welfare Department including Tribal Welfare Residential Educational Institutions Society;
- iii) Backward Classes Welfare Department including Backward Classes Welfare Residential Educational Institutions Society;
- iv) Women & Child Welfare Department;
- v) Andhra Pradesh Residential Educational Institutions Society;
- vi) Disabled Welfare Department;
- vii) Minorities Welfare Department;
- viii) K.asturba Gandhi Balika Vidyalyaya (KGBVs)

3. Government, after consideration of the matter, hereby order that the price of rice being supplied to all pre-metric, post-metric hostels run by the Departments mentioned at para-2 above be fixed at Rs. 1/- per K.G., with immediate effect.
4. The Commissioner of Civil Supplies, A.P., Hyderabad, is requested to ensure supply of rice every month to the institutions indicated above at Rs.1/- per K.G.
5. This order issues with the concurrence of Finance Department vide their U.O.No.3 I 80/92/A2/Expr.AHFFCS&E, dated 06-03-2013.
